SHOW GUIDELINES

All original fine art and fine craft is eligible, including but not limited to jewelry, painting, drawing, photography, Giclée prints, sculpture and furniture. Arts Alive Festival will provide a 10' x 10' booth space for all participants. Artists must provide their own tent. All artists must be set up by the start time: 10:00 a.m. Electricity will not be available. Generators are not allowed. Artists must be 18 years of age or older or accompanied by a guardian. Artists or their representatives must be present throughout the festival. The festival will take place rain or shine.

JURY PROCEDURE

All applications must be received by June 13, 2008. Although there is no jury fee, the Arts Alive Festival reserves the right to accept or reject any application at its discretion. No mass-produced or commercially manufactured work will be eligible. Entry fees will be refunded by June 20 to artists whose applications are not accepted.
